### To get an electronic version of the Legal Principles:

Filling the form requires subscribing to Dubai Courts e-Services and presenting the following documents:

**For Companies and Institutions:** (Commercial License – Power of Attorney if one exists from the company manager to the party or a letter issued from the company manager authorizing the employee to follow up with the Courts and submitting the application – passport copy or identity cards of the company manager – passport copy or identity card of the representative in case of a Power of Attorney) Fees (AED 1000).

**For individuals:** Submit a copy of the identity card and a fee of (AED 1000).

This service is also available to Law Offices.

### To get the electronic version of the Legal Principles from the Apple Store:

Download the program from the Apple Store on iPads or iPhones.
