Dubai Courts Services, Smart Services Terms of User Agreement

Purpose and Objective
Welcome to the "Dubai Courts" E-Services, Smart Services. We invite you to carefully read these terms and conditions, which set forth the principles and obligations that are necessary for fruitful use of the services available on the Dubai Courts e-services portal and Dubai Courts Smart Services Applications by outlining user's obligations and terms of use.

Definitions:
The following words shall mean as follows:

E-Services and Smart Services The electronic services and Smart Services provided by Dubai Courts to the subscribed users or other users, in any electronic or Smart form e.g. registration of cases of different kinds and stages, e-payment of fees, case petitions, attestations and applications submitted to Public Notary.

User: Anyone who has access to all contents and materials available on Dubai Courts website and Smart Services Application or transactions with the same in any form, whether as a subscriber through his service account (username and password given to him), in which case he is called a subscriber, or as a non-subscriber.

Contents All contents of service, such as software and databases and the data files, written texts, photocopies of documents or other photocopied or written materials contained therein.

Declaration of Acceptance of and Compliance with the Terms and Conditions, and Acceptance of Revised and Updated Terms and Conditions
By accessing this Dubai Courts website, Smart Services Applications, the user accepts the terms of use contained in this Agreement. Dubai Courts reserve the right to review the aforesaid terms at any time and to announce any amendment or change to such terms, on the portal website.
The user shall be responsible for periodically checking any amendments. Continued access of the Dubai Courts website, Smart Services Applications, after effecting any amendments to the terms prescribed therein, shall be deemed acceptance of the amended terms and conditions by the user.

Suspension or Termination of Service
Loss of data, delay of operations for technical reasons, content of third party websites accessed through the portal, viruses blocking the access to service or incompatibility of service with other services, software and hardware; delay or failure of the user to start or complete connection, abuse or inability to use the electronic and smart services provided; content, information or any other materials displayed on other websites accessed through the links available through Dubai Courts website and Smart Services Applications, nor shall it be liable for the use of the services of such other websites by the user.

Dubai Courts may have to temporarily suspend the service for operational reasons such as maintenance of systems, development or upgrading of services or for other urgent reasons without prior notice and without determining the suspension period.
Any breach of the current terms of service by the user will result in closing his account or immediate termination of all operations pertinent thereto without prior notice.

The cancellation of one or more clauses of these terms for being illegal or non-enforceable will not affect the legality and enforceability of the other terms.

Disputes, Arbitration and Applicable Law
The user shall accept the current terms of service and the future amendments which may be made thereto. Any dispute arising from this service, whether related to interpretation or performance, shall be brought to specialized courts according to UAE laws and shall be subject to the jurisdiction of Dubai Courts.
